5. Curriculum information

Our teaching programmes and assessments reflect the content and challenge of the National Curriculum. At Key Stage 3 pupils take the following subjects: English, mathematics, science, art, geography, history, computing, modern foreign languages (French, German and Spanish), music, PE, PSHE (delivered via form time), social studies/religious education, design and technology. Selected pupils also follow the Lexia reading scheme.

At Key Stage 4, starting in year 9 pupils follow a personalised pathway. All pupils take the core subjects of Maths, English language, English literature, PE (not examined), PSHE (delivered via form time and topic days) and Combined Science (double award) OR separate sciences (biology, chemistry, physics).

Nearly all pupils with be entered for the EBacc (English Baccalaureate); they will study the above subjects and History or Geography (or both) and French, German or Spanish.
